The Village of Montrose does not bind itself to accept any bid, nor will it assign any reason for the rejection of a bid.

### **Terms and Condition:**

- Equipment listed is open on an “As-is” and “Where- Is” basis.
- All sales are final. Equipment is being sold as-is, and there are no guarantees expressed or implied. Buyers are responsible to satisfy themselves as to the condition of goods being purchased before final sale and removal from site.
- A reserve price of \$15,000 has been set and as such the equipment will only be sold to a buyer with a bid greater than \$15,000 CAD.
- Equipment must be collected from the Village of Montrose following payment in full.
- Purchaser is responsible for removing all Village of Montrose decaling and identification within one week of purchase.
- Applicable taxes (PST and GST) relating to equipment purchase will be added to the accepted bid amount.

- Payment in full and possession of the equipment by the buyer must be completed prior to Monday, November 9, 2020.
