- a) a review of the definition of the term "Recreation" used to qualify facilities, programs and services within the scope of the sub-regional recreation service, and
- b) a review of the principles, objectives, and policies that govern the allocation of funds to delivery agencies of subregional recreation services, and
- a review of agreements, contracts, and other instruments adopted to ensure transparency of and accountability for sub-regional recreation service expenditures, and
- d) a review of the sub-regional recreation service's system and its effectiveness in:
 - (i) achieving a balance between local costs and local tax payments,
 - (ii) providing incentives to reduce spending,
 - (iii) reducing political strife between communities, and
 - (iv) providing consistency within, between and among participating communities.
